**AGREED ORDER**

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Antuanya "Bo" DeBose, and Respondent Stephen Mac Purvis, and agree to entry of this Order.

**JURISDICTION**

The parties stipulate to the following:

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O.S. §§ 1301-1340.
2. Respondent Stephen Mac Purvis ("Respondent") is a professional bondsman in the State of Oklahoma holding license number 200283. Respondent Purvis' address of record is 1508 Colt Drive, Durant, Oklahoma 74701-7833.
3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §1310(A) and (B).

4. The Insurance Commissioner, pursuant to 59 O.S. §1311.1, has appointed an independent hearing examiner who shall sit as a quasi-judicial officer.
5. Informal disposition of this matter may be made by agreed settlement pursuant to 75 O.S. §309(E).

**STIPULATIONS OF FACT**

1. On or about December 18, 2020, an appearance bond was executed as follows:

2. On or about April 1, 2021, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about April 9, 2021 by the Bryan County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent to his address of record with return receipt requested within thirty (30) days after the Order's filing.
3. Respondent received a copy of the Order and Judgment of Forfeiture on April 27, 2021.
4. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture was July 27, 2021.
5. The forfeiture was untimely paid March 10, 2022.
6. Pursuant to 59 O.S. §1332(C)(1), the bail bondsman shall have ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk or mailing of the notice if no receipt is made to return the defendant to custody.

7. Pursuant to *59 O.S. §1332(D)(1)*, if, within ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made, the defendant is not returned to custody, or the forfeiture has not been stayed, the bondsman and, if applicable, the insurer whose risk it is shall deposit cash or other valuable securities in the face amount of the bond with the court clerk ninety-one (91) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made.

8. Pursuant to *59 O.S. §1310(A)(28)*, the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act for failing to pay any fees to a district court clerk as are required by this title or failing to pay any fees to a municipal court clerk as are required by this title or by Section 28-127 of Title 11 of the Oklahoma Statutes.

9. Pursuant to *59 O.S. §1310(B)*, in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

#### CONCLUSIONS OF LAW

1. Respondent has violated *59 O.S. §§ 1310(A)(2)* and *(A)(28)* by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days of receipt of the Order and Judgement of Forfeiture in accordance with the provisions of *59 O.S. §1332* and *Okla. Admin. Code 365:25-5-40(b)*.

**ORDER**

**IT IS THEREFORE ORDERED** by the Insurance Commissioner and **AGREED** by Respondent that he is hereby **FINED** in the amount of **FIVE HUNDRED DOLLARS (\$500.00)**. The fine shall be paid within thirty (30) days from the date of this Agreed Order and made payable to the Oklahoma Insurance Department, located at 400 NE 50<sup>th</sup> Street, Oklahoma City, Oklahoma 73105. Failure to comply with a proper order of the Commissioner will result in further administrative action.


