FINAL ADMINISTRATIVE ORDER

On May 4, 2022, a show cause hearing was held at the Oklahoma Insurance Department (“OID”) on OID’s *Notice of Hearing and Order to Show Cause* (“Notice”), filed March 24, 2022. The hearing was held at the offices of OID before Independent Hearing Examiner Stephan Mathis. Present at the hearing were Antuanya “Bo” DeBose, Assistant General Counsel for OID and Lewis Garrison, Director of Bail for OID. Respondent Ladonna C. Hobbs (“Respondent Hobbs”) and Respondent James Keith Eggenberg (“Respondent Eggenberg”) appeared pro se.

Witnesses were sworn and testified, exhibits were admitted, and argument of the parties heard.

PROCEDURAL FINDINGS

1. That the OID has jurisdiction over the subject matter of this action pursuant to the Oklahoma Insurance Code, *36 O.S. §§101-7401*, and the Oklahoma Bail Bond Act, *59 O.S. §§1301 – 1340*.
2. That the Insurance Commissioner has the authority to render an Order concerning the above styled matter and has lawfully appointed Independent Hearing Examiner, Stephan Mathis, who shall sit as a quasi-judicial officer pursuant to *59 O.S. §1311.1*.
3. That Respondent Hobbs is a licensed bail bondsman in the State of Oklahoma holding license number 199626. Respondent Hobbs' address of record is PO Box 366, Calera, Oklahoma 74730-0366.
4. That Respondent Eggenberg is a multicounty agent bondsman in the State of Oklahoma holding license number 199991. Respondent Eggenberg's address of record is PO Box 1562, Ardmore, Oklahoma 73402-1562.
5. That pursuant to *59 O.S. §1310(A)(28)*, the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act for failing to pay any fees to a district court clerk as required by this title.
6. That pursuant to *59 O.S. §1310(B)*, in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.
7. That Petitioner afforded both Respondents an opportunity for hearing by sending the *Notice* by certified mail, return receipt requested, and by first class U.S. mail on March 24, 2022. The *Notice*, filed on March 24, 2022, stated the matters asserted, and stated the

time, place, and nature of the hearing, cited legal authority and jurisdiction, and referred to particular sections of the statutes involved.

8. The hearing was recorded electronically by an employee of the Oklahoma Insurance Department. Neither party requested a full stenographic record of the proceedings.

52. Pursuant to 59 O.S. §1332(C)(1), the bail bondsman shall have ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk or mailing of the notice if no receipt is made to return the defendant to custody.

53. Pursuant to 59 O.S. §1332(D)(1), if, within ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made, the defendant is not returned to custody, or the forfeiture has not been stayed, the

bondsman and, if applicable, the insurer whose risk it is shall deposit cash or other valuable securities in the face amount of the bond with the court clerk ninety-one (91) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made.

54. Pursuant to 59 O.S. §1310(A)(28), the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act for failing to pay any fees to a district court clerk as are required by this title or failing to pay any fess to a municipal court clerk as are required by this title or by Section 28-127 of Title 11 of the Oklahoma Statutes.

55. Pursuant to 59 O.S. §1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

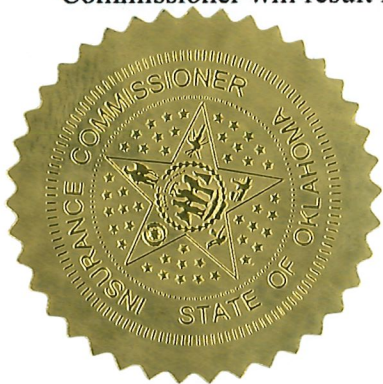
CONCLUSIONS OF LAW

56. Based upon the provided findings of fact there is clear and convincing evidence to find that Respondent Hobbs and Respondent Eggenberg have violated 59 O.S. §§ 1310(A)(2) and (A)(28) on six (6) occasions by failing to return the defendant(s) to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and Okla. Admin. Code § 365:25-5-40(b).

ORDER

IT IS THEREFORE ORDERED that Respondent Hobbs and Respondent Eggenberg are each **CENSURED** and **FINED One Thousand Five Hundred Dollars**

(\$1,500.00) and are ordered to pay the costs of the proceeding in the amount of **Three Hundred Fifty Dollars (\$350.00)**. The fine and court costs shall be submitted to the Oklahoma Insurance Department within thirty (30) days of the date of this Final Administrative Order and made payable to the Oklahoma Insurance Department. The fine shall be sent to the Oklahoma Insurance Department located at 400 NE 50th Street, Oklahoma City, Oklahoma 73105. Failure to comply with a proper order of the Commissioner will result in further administrative action
