**AGREED ORDER**

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Antuanya "Bo" DeBose, and Respondent(s) Ladonna C. Hobbs and James Keith Eggenberg and agree to entry of this Order.

**JURISDICTION**

The parties stipulate to the following:

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O.S. §§ 1301-1340.
2. Respondent Ladonna C. Hobbs ("Respondent Hobbs") is a licensed bail bondsman in the State of Oklahoma holding license number 199626. Respondent Hobbs' address of record is PO Box 366, Calera, Oklahoma 74730-0366.
3. Respondent James Keith Eggenberg ("Respondent Eggenberg") is a multicounty

agent bondsman in the State of Oklahoma holding license number 199991. Respondent Eggenberg's address of record is PO Box 1562, Ardmore, Oklahoma 73402-1562.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to *59 O.S. §1310*.

5. Informal disposition of this matter may be made by agreed settlement pursuant to *75 O.S. §309(E)*.

### **FINDINGS OF FACT**

#### **Case No. 22-0204-DIS**

1. On or about April 5, 2021, an appearance bond was executed as follows:

2. On or about November 17, 2021 the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about December 1, 2021 by the Bryan County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent Hobbs and Respondent Eggenberg to their address of record with return receipt requested within thirty (30) days after the Order's filing.

3. Respondent Hobbs' copy of the Order and Judgment of Forfeiture was received December 14, 2021.

4. Respondent Eggenberg's copy of the Order and Judgment of Forfeiture was

returned unclaimed.

5. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture was March 15, 2022.

6. The forfeiture was not timely paid, and the Defendant was not timely returned to custody.

7. The bond was ordered exonerated and vacated on June 15, 2022 by the Bryan County District Court.

**Case No. 22-0205-DIS**

8. On or about September 27, 2021 an appearance bond was executed as follows:

9. On or about November 17, 2021 the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about December 1, 2021 by the Bryan county District Court. A true and correct copy of the Order and Judgement of Forfeiture was mailed to Respondent Hobbs and Respondent Eggenberg to

their address of record with return receipt requested within thirty (30) days after the Order's filing.

10. Respondent Hobbs received a copy of the Order and Judgment of Forfeiture on or about December 14, 2021.

11. Respondent Eggenberg's copy of the Order and Judgment of Forfeiture was returned unclaimed.

12. The ninety first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture was March 15, 2022.

13. The forfeiture was not timely paid, and the Defendant was not timely returned to custody.

14. Proof that the Defendant is deceased was filed June 8, 2022.

16. On or about November 18, 2021 the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about December 7, 2021 by the Bryan County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent Hobbs and Respondent Eggenberg to their address of record with return receipt requested within thirty (30) days after the Order's

filing.

17. Respondent Hobbs' copy of the Order and Judgement of Forfeiture was received December 14, 2021.

18. Respondent Eggenberg's copy of the Order and Judgement of Forfeiture was received December 29, 2021.

19. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment was March 15, 2022.

20. The forfeiture was not timely paid, and the Defendant was not timely returned to custody.

21. The bond was ordered exonerated and vacated on June 15, 2022 by the Bryan County District Court.

**Case No. 22-0207-DIS**

22. On or about November 1, 2021, an appearance bond was executed as follows:

23. On or about December 1, 2021 the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about December 10, 2021 by the Bryan County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent Hobbs and Respondent Eggenberg to their address of record with return receipt requested within thirty (30) days after the Order's filing.

24. Respondent Hobbs' copy of the Order and Judgement of Forfeiture was received December 14, 2021.

25. Respondent Eggenberg's copy of the Order and Judgement of Forfeiture was returned unclaimed.

26. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture was March 15, 2022.

27. The forfeiture was not timely paid, and the Defendant was not timely returned to custody.

28. The bond was ordered exonerated and vacated on July 28, 2022 by the Bryan County District Court.

29. Pursuant to *59 O.S. §1332(C)(1)*, the bail bondsman shall have ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk or mailing of the notice if no receipt is made to return the defendant to custody.

30. Pursuant to *59 O.S. §1332(D)(1)*, if, within ninety (90) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made, the defendant is not returned to custody, or the forfeiture has not been stayed, the bondsman and, if applicable, the insurer whose risk it is shall deposit cash or other valuable securities in the face amount of the bond with the court clerk ninety-one (91) days from receipt of the order and judgement of forfeiture from the court clerk, or mailing of the notice if no receipt is made.

31. Pursuant to *59 O.S. §1310(A)(28)*, the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act for failing to pay any fees to a district court clerk as are required by this title or failing

to pay any fees to a municipal court clerk as are required by this title or by Section 28-127 of Title 11 of the Oklahoma Statutes.

32. Pursuant to *59 O.S. §1310(B)*, in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

#### CONCLUSIONS OF LAW

1. Respondent Hobbs and Respondent Eggenberg have violated *59 O.S. §§ 1310(A)(2)* and *(A)(28)* on four (4) occasions by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days of receipt of the Order and Judgement of Forfeiture in accordance with the provisions of *59 O.S. §1332* and *Okla. Admin. Code 365:25-5-40(b)*.

#### ORDER

**IT IS THEREFORE ORDERED** that Respondent Hobbs and Respondent Eggenberg are each **CENSURED** and **FINED One Thousand Dollars** (\$1,000.00). The fine shall be submitted to the Oklahoma Insurance Department within thirty (30) days of the date of this Agreed Order and made payable to the Oklahoma Insurance Department. The fine shall be sent to the Oklahoma Insurance Department located at 400 NE 50<sup>th</sup> Street, Oklahoma City, Oklahoma 73105. Failure to comply with a proper order of the Commissioner will result in further administrative action


