
ORDER OF DISMISSAL

On October 4, 2024, the Oklahoma Real Estate Appraiser Board, an agency of the State of Oklahoma (the "Board"), held a regular meeting in compliance with the Open Meeting Act, 25 O.S. §301 et seq., with advance public notice published through the agenda therefore having posted at its temporary meeting location in prominent public view for not less than twenty-four (24) hours prior to said regular meeting at the main entrance of the Oklahoma Insurance Department, 400 N.E. 50th Street, Oklahoma City, Oklahoma 73105 and at the Board of Professional Engineers and Land Surveyors, 220 NE 28th Street, Oklahoma City, Oklahoma 73105 on October 2, 2024, at 9:30 a.m. During the October 4, 2024, regular meeting, the Board discussed the posted agenda item of possible action regarding Complaint #23-045 against appraiser John H. Jones, (hereinafter "Jones") upon a recommendation of dismissal by the Board's prosecutor, Rex Duncan, dated October 4, 2024.

The Board having discussed the matter and being fully informed, voted to accept the recommendation of the Board's Prosecutor to dismiss Complaint #23-045. **THEREFORE**, it is hereby ordered by the Oklahoma Real Estate Appraiser Board that Complaint #23-045 should be and hereby is dismissed.

IT IS SO ORDERED this 4th day of October 2024.

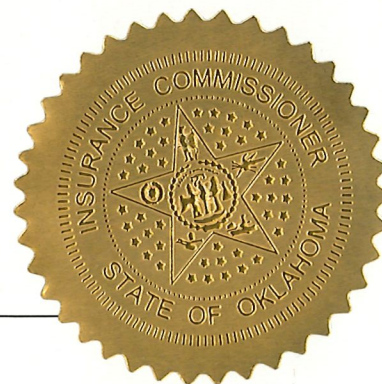




