CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Kim Hunter, and Respondent Tag Warranty Corp., by and through counsel, Mark Celichowski, and stipulate to the following facts and applicable laws. The parties agree to the entry of this Consent Order.

JURISDICTION

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 *et seq.*, including the Service Warranty Act, 15 O.S. §§ 141.1 *et seq.*

2. Tag Warranty Corp. d/b/a TAG Warranty Corp. (“Respondent”) is a registered service warranty association in the State of Oklahoma, SBS Number 44198980. Its mailing address of record is c/o The Amynta Group, 2200 Highway 121, Ste. 100, Bedford, TX 76021-5983.

3. Informal disposition of this matter may be made by agreed settlement pursuant to 75 O.S. § 309(E).

STIPULATIONS OF FACT

4. Pursuant to 15 O.S. § 141.14(A), service warranty associations shall annually, on or before the first day of May, file with the Insurance Commissioner its annual financial statement.
5. On or about May 11, 2021, Respondent submitted to the Oklahoma Insurance Department (“OID”) its 2021 annual financial statement.
6. Respondent’s 2021 annual financial statement was ten (10) days late.
7. On or about October 20, 2022, Respondent submitted to the OID its 2022 annual financial statement.
8. Respondent’s 2022 annual financial statement was one hundred seventy-two (172) days late.
9. Pursuant to 15 O.S. § 141.14(B), the Insurance Commissioner may levy a fine of up to \$100.00 a day for each day an association neglects to file its financial statement in the form and within the time provided by the Service Warranty Act.

CONCLUSIONS OF LAW

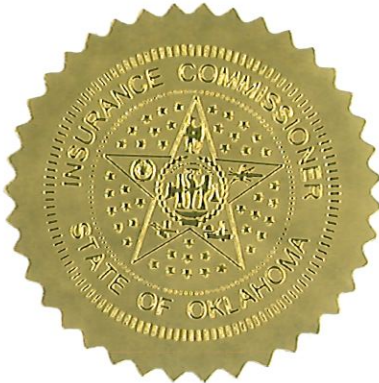
10. Respondent violated 15 O.S. § 141.14(A) when it untimely submitted its 2021 annual financial statement on May 11, 2021, and untimely submitted its 2022 annual financial statement on October 20, 2022.

ORDER


IT IS THEREFORE ORDERED by the Insurance Commissioner and **CONSENTED** to by Respondent that Respondent Tag Warranty Corp. d/b/a TAG Warranty Corp. is hereby **FINED** in the amount of **NINE THOUSAND ONE HUNDRED DOLLARS (\$9,100.00)**. The fine is to be paid within thirty (30) days of this Order and made payable to the Oklahoma Insurance

Department located at 400 NE 50th Street, Oklahoma City, Oklahoma 73112. Failure to comply with a proper order of the Commissioner may result in further administrative action.
