**CONDITIONAL ADMINISTRATIVE ORDER  
AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner,  
by and through counsel, Andrea M. Golden, and alleges and states as follows:

**JURISDICTION**

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 - 7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301 - 1340.

2. Jacquelynn Diahann Wolfington (“Respondent Wolfington”) is a licensed bail bondsman in the State of Oklahoma holding license number 199482. Respondent Wolfington’s mailing address of record is P.O. BOX 1587, Guthrie, Oklahoma 73044-1587.

3. Kirk Glen Osborn (“Respondent Osborn”) is a multicounty agent bondsman in the State of Oklahoma holding license number 200066. Respondent Osborn’s mailing address of record is P.O. BOX 1587, Guthrie, Oklahoma, 73044-1587.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.

5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than \$250.00 nor more than \$2,500.00 for each occurrence.

6. If Respondents request a hearing in writing in this matter, pursuant to OAC 365:1-7-1, the Insurance Commissioner, pursuant to 59 O.S. § 1311.1, will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondents.

**FINDINGS OF FACT**

7. On or about September 9, 2023, an appearance bond was executed as follows:

Defendant:	Dane Lee Armstrong
Case Number(s):	CM-2022-257
City/County:	Logan County
Surety:	Kirk Glen Osborn
Bondsman:	Jacquelynn Diahann Wolfington
Power Number(s):	7307
Bond Amount(s):	\$1,500.00

8. On or about January 12, 2023, the Defendant failed to appear, and the bond was declared forfeited. The Logan County District Court issued an Order and Judgment of Forfeiture on or about January 27, 2023. On or about February 13, 2023, a true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent Wolfington and Respondent Osborn at their respective mailing address of record with return receipt requested within thirty (30) days after the Order's filing.

9. On March 3, 2023, Respondent Wolfington received a copy of the Order and Judgment of

Forfeiture.

10. On March 3, 2023, Respondent Osborn received a copy of the Order and Judgment of Forfeiture.

11. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was June 2, 2023.

12. On June 7, 2023, the forfeiture was untimely paid.

### CONCLUSIONS OF LAW

13. Respondents have violated 59 O.S. §1310(A)(6) and (28), by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41.

### ORDER

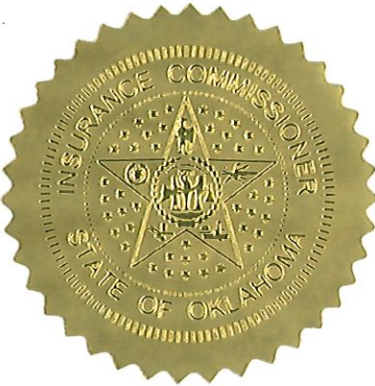
**IT IS THEREFORE ORDERED** by the Insurance Commissioner that Respondent Wolfington is **FINED** Two Hundred Fifty Dollars (**\$250.00**) and that Respondent Osborn is **FINED** Two Hundred Fifty Dollars (**\$250.00**). The fines are to be paid within thirty (30) days of the date of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department located at 400 NE 50th Street, Oklahoma City, Oklahoma 73105. Failure to comply with a proper order of the Commissioner will result in further administrative action.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner that this Order is a Conditional Order. Unless either Respondent requests a hearing with respect to the Findings of Fact set forth above within thirty (30) days of the date of this Conditional Order, the penalties set forth above will become a Final Order on the thirty-first (31st) day following the date of mailing this Order. A request for hearing should be in writing and



addressed to Andrea M. Golden, Oklahoma Insurance Department, Legal Division, 400 NE 50th Street, Oklahoma City, Oklahoma 73105. The request for hearing must state the grounds for the request to set aside or modify the Order and must be served on the Oklahoma Insurance Department within the thirty (30) days allotted. The proceedings on such requested hearing will be conducted in accordance with the Oklahoma Insurance Code, 36 O.S. §§ 101 - 7401, and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 through 324. If either serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order will act as a notice of the matters to be reviewed at the hearing and the Findings of Fact, Conclusions of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
